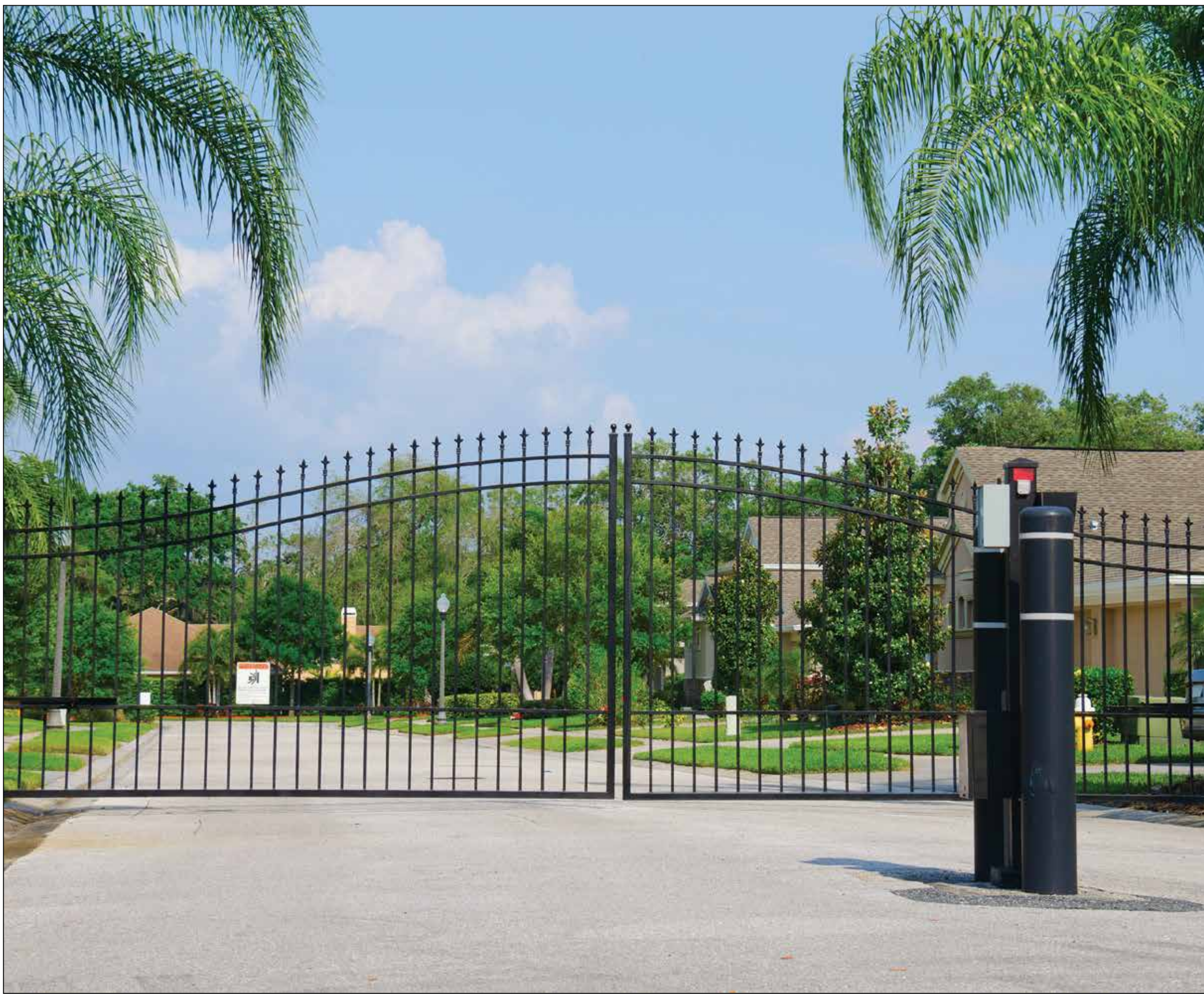

#### Review the HOA Rules Before Buying
